Australian Warning System

Australia's emergency warning system is changing. The new Australian Warning System is a consistent national approach, bringing together different warning systems for different types of hazards across Australia.

Three warning levels will indicate the level of extremity for hazards including bushfire, flood, storm, cyclone, extreme heat, and severe weather.

Advice An incident has started. There is no immediate danger. Stay up to date in case the situation changes.

Watch and Act There is a heightened level of threat. Conditions are changing and you need to start taking action now to protect you and your family.

Emergency Warning An Emergency Warning is the highest level of warning. You may be in danger and need to take action immediately. Any delay now puts your life at risk.

2021: WHAT WE'VE DONE SO FAR

Identified recovery needs through development of Alpine CRC Community Recovery Plan: One of the major achievements of 2021 has been the development and distribution of the Alpine CRC Community Recovery Plan. The Plan came together as a result of a community survey conducted in 2020, where identified needs and priorities were placed into four key areas of focus: preparedness, response, recovery, and resilience. The Plan identifies pathways to implementation for flagship projects, including those that require coordinated regionwide response and those that occur at a community level. Implemented the Plan through alignment with existing and new government and community projects, processes, and initiatives: The Alpine CRC has used the Plan and the projects listed within it to advocate for the needs of our communities, to support opportunities for funding and resourcing, and to hold governments and organisations accountable to their commitments to the community. The Alpine CRC has directly advocated to the Alpine People and Wellbeing Recovery Working Group, Alpine Resilience Committee, Alpine Shire Council, Bushfire Recovery Victoria (BRV), Department of Land, Water and Planning, Federal Government Senate Inquiry into Bushfires, the Federal Member for Indi, Inspector General of Emergency Management Inquiry, Municipal Bushfire Recovery Committee, State Bushfire Recovery Co-ordinating Committee, and Victorian Government State Legislative Council.

This advocacy has enabled agencies to act. Relevant government agencies have advised that the promotion of community needs has encouraged them to reprioritise and influenced the development of their recovery programs.

Reviewed over 75 community projects for inclusion as a community recovery priority: Community organisations seeking funding for their project in any grant processes may have sought a letter of support from the Alpine

CRC. The committee prioritised projects that are local community- or business-led, are of benefit to the local community, and meet one or more of the bushfire recovery objectives outlined in the Plan.

Advocated for improvements and changes to the LER grants process:

The state government bushfire grants programs were and continue to be welcomed by the community. However, the processes are not always aligned with achieving the intended outcome of building community and economic recovery in the disaster affected regions. While some changes have been made, the Alpine CRC continued to advocate for changes to the process to achieve better outcomes for government money and the recovery of our communities.

Successfully advocated for the Alpine Resorts regions to be included in state and federal government grants: The Alpine Resorts are exclusion areas from the State LGA process, which was initially reflected in the BRV Local Economic Recovery (LER) grants program. The successful advocacy for inclusion of the Alpine Resort areas set a precedent and changed awareness and perception about these important economic and community portions of our region at government levels. We hope this change to inclusion of the Alpine Regions for broad based programs is a lasting legacy.

Continued advocacy to address insurance: The Alpine CRC are continuing to seek a solution to the inadequate, exorbitant, or sometimes unobtainable insurance businesses are facing following the bushfires.

Produced this monthly digital newsletter, highlighting key areas of concern within the community: The CRC sought presentations and mutual dialogue from organisations responsible for the key areas of concern identified in the community survey. The committee sought presentations and mutual dialogue from organisations responsible, including progress with bushfire recovery efforts in our public lands, development of telecommunications infrastructure, available mental health programs, and bushfire preparedness initiatives.

Advocated for successful delivery a bushfire preparedness flyer: The Alpine CRC requested that Alpine Shire Council include a specific bushfire preparedness newsletter with the August 2021 rates notice, delivered to every ratepayer in the Alpine Shire.

Planned delivery of Preparedness Fair: The Alpine CRC had commenced work with the Myrtleford Show Committee and the Alpine Shire Council to bring a Preparedness Fair to the Myrtleford Show, which would have been an expansion on the Shows regular emergency agencies. The necessary cancellation of the Show in 2021 has delayed this project but we are looking towards delivery in 2022.

Distributed event funding to local communities: As a result of funding provided by BRV, the Alpine CRC was able to distribute funding for our local communities to hold end of year activities to promote community connectedness.

Committed a great number of volunteer hours: During 2021, the Alpine CRC held thirty-seven two-hour meetings, and attended numerous working group meetings and regular agency meetings, in addition to specific advocacy presentations. The required preparation and presentation for all committee members represents a generous contribution of volunteer time.

The committee also recognises the considerable volunteer time provided by our local community groups in developing and implementing projects and the hours and resources involved in applying for grants.

As our communities transition from the recovery stage of the 2019/20 bushfire event to business as usual, we will be reflecting our ongoing role and purpose in early 2022. Our next steps will be to provide an update on the status of projects in the Plan and conduct a review to improve preparedness activities in a sustainable ongoing manner across the region.
