Notice of intention to make a local law Governance Local Law (2020)

At its ordinary council meeting on 7 July 2020, Alpine Shire Council endorsed the proposed Governance Local Law (2020) for the purpose of seeking public submissions.

In accordance with section 119(2) of the *Local Government Act 1989*, the objectives of the proposed local law are to:

- Regulate the use of the Alpine Shire Council Common Seal;
- Provide for offences in relation to unauthorised use of the Common Seal or any device resembling the Common Seal; and
- Provide for offences in relation to Council meetings and Delegated Committee meetings.

A copy of the proposed local law and community impact statement may be inspected at the Bright Council Office, Customer Service Centres in Mount Beauty and Myrtleford, and on Council's website: www.alpineshire.vic.gov.au/onexhibition.

Any person affected by the proposed local

law may make a submission in accordance with section 223 of the *Local Government Act 1989*. A submitter may request that they or their representative is heard before Council in support of their submission. The request to be heard, and the names of the persons or representatives, must be clearly specified in the written submission. The intended date for hearing submissions will be the afternoon of Tuesday 18 August 2020. Council will contact those wishing to be heard to confirm the date and the time along with arrangements for presenting to Council.

Written submissions must be received by Council no later than 12 noon on Friday 14 August 2020 and should be addressed to:

KERBSIDE PRUNING COLLECTION

Council offers an annual collection of garden prunings from residents' naturestrips.

Collection will take place at:

Myrtleford: Monday 13 July - Friday, 17 July

Mount Beauty and Tawonga: Monday 20 July - Friday, 24 July

Porepunkah and Wandiligong: Monday 27 July - Friday 31 July

Bright: Monday 3 August - Friday 7 August

- Prunings will only be collected once per household on or near the date specified for each township. Households placing unacceptable material or not abiding by the timetable will be responsible for removing these items from the road reserve.
- Prunings placed on a nature strip too early will constitute a local law infringement i.e. no more than one week prior to the collection week.
- This collection program is for PRIVATE TREE PRUNINGS ONLY. Pruning of Council owned trees will constitute a local law infringement.
- Prunings must be:
 - Neatly stacked with ends facing the kerbside on the nature strip, not obstructing vehicular or pedestrian traffic
 - Have a minimum diameter of 20mm for each pruning
 - Have a maximum diameter of 200mm for each pruning
 - o Be NO longer than 2 metres in length
 - Be LESS than 3 cubic metres total loose volume
 - On the nature strip by the specified date
 - o Not bound by wire

The following materials WILL NOT be collected or chipped:

- Vines and creepers
- Blackberries, roses, bamboo, flax and palms
- Tree stumps, and tree roots
- Spiky citrus varieties
- Wire, string, metal, plastics etc.
