ASSESSMENT CRITERIA

The Minister for Planning in his Minister’s Guideline (MG/12 dated June 2006) has set out the objective and decision guidelines that Council must have in regard to when considering varying a design and siting standard.

Note: If any matter set out in the guideline is not met, then Council **must refuse** consent.

Objective: To reduce the impact of increased stormwater run-off on the drainage system and to facilitate on-site stormwater infiltration.

Decision Guidelines: The reporting authority may give its consent where a single dwelling, does not comply with regulation 77 of the Building Regulations 2006, if -

(a) the amount of impermeable surfaces would be consistent with that of existing development on the allotment if applicable;
or

(b) the capacity of the drainage network servicing the allotment is able to accommodate the additional stormwater that the development will cause; or
